SAFETY / SECURITY ZONES & THE AUXILIARY

From the Director of Auxiliary:

The Auxiliary role in support of Safety/ Security zones is to observe, educate and report during routine Safety Patrol operations which can be accomplished from outside the zone.

From the Operations Policy Manual, COMDINST M16798.3E, Chapter 4, Section A.11:

"Auxiliarists operating facilities without CG Boarding Officers onboard may function only in an advisory or information mode when directing the movement of boats in the vicinity of the zone, and may not exercise law enforceAdditionally, Auxiliary Vessels are not permitted to transit or enter Safety/Security Zones without prior authorization. This means that you must have received direct authorization from an appropriate Coast Guard Authority to enter a Safety/Security zone. This Authority would only be the Coast Guard Sector that is responsible for the issuing of the Vessel's orders or the Coast Guard unit that is holding your radio guard in the event of an operational requirement or other circumstance such as traffic avoidance or safety or patrol issue.

NEW V-DEP'T WEBSITE



Kelly L. Townsend, DIR-V has announced that the National Vessel Examinations and RBS Program Visitation Depart-

ment, in collaboration with the National IT Group, has developed a new website that will replace the venerable "safetyseal.net" site that has served us so well over two decades. The URL or the new site will be

The **safetyseal.net** and **vesselsafetycheck.org** domains, in which there is considerable brand equity, will be retained for the foreseeable future, and will simply redirect to the new site, including all document links. Those domains represent our collaboration with the US Power Squadrons, which continues with the new site.

In conjunction with the rollout of the new V-Department website, a new "I want a VSC" System has been implemented. It is based upon the successful model used by the H-Department for new member inquiries.

This new systems finds the five (5) nearest examiners, based on their address of record in AuxOfficer/AuxDirectory, and sends them all a "VE request" email, providing requestor contact information and the general location of the boat. Any one of the five is free to respond. The only requirement is that whoever does respond does a "Reply all."

HOW TO REPORT ICS COMPLETIONS

Donna Cole is requesting ICS certificates be sent to her by email. The online courses generate a certificate as a PDF. No need to print that out, just forward the file to her email address **donnacole.uscgaux@verizon.net** Any certificate that is handed out can be faxed to her at 240-359-5364. The process takes a few minutes. In contrast, certificates in hard copy can take her several weeks to process. Any certificates that go to her electronically will be processed the same day. Her goal is 24 hour turnaround time. Efforts to encourage email submissions will help her to achieve that goal, and also will better serve the membership.
