With great sadness we note the passing of a friend, shipmate and flotilla member, Ed Sussdorff.

A member of the Auxiliary since November 5, 1995, Edmund L. Sussdorff Jr., 82, of Lake Street, Port Kent, died Sunday, Nov. 18, at the CVPH Medical Center in Plattsburgh with his family by his side. He was born in Port Kent, July 15, 1930, the son of Edmund and Margaret (Muir) Sussdorff.

and later received his Master's degree in Education from Plattsburgh State

University. Although Ed held many positions throughout his life, his true passion was teaching. He retired from Peru Central School Primary in 1992.

He was a member of the Keeseville Kiwanis Club, Civil Air Patrol, US Coast Guard Auxiliary Flotilla 15-8, and a longtime supervisor at the Peru Central School Federal Credit Union. He enjoyed an active lifestyle driving his antique cars, flying his seaplane, motorcycling, and boating on Lake Champlain.

# **Hurricane Sandy**

One of our flotilla members, Aline Pepe, FSO-MS, travelled to the New York area earlier this month to help with relief efforts there following Hurricane Sandy. Pepe has many years of prior disaster relief training and did this entirely on her own with no pretense of representing the Auxiliary. In this photo, she's tying on her boots getting ready to head out to distribute supplies. In the bottom photo, her daughter Athena looks over a map of the affected area. Here are some of Alene's comments:

"Well, first I knew I wanted to go help. So I made a list of things people would be needing and posted them about town leaving one at Keene Valley Congregational Church. I was very happy as calls started coming in with donations of needed items, one lady even giving me some gas money, another sending me a check from Vermont to buy supplies. But my mouth dropped open when I got a call from the church, telling me they could have a couple of people there to help me load the car, it was just unbelievable how many things they collected. I had to spread it all out on the driveway, organize it and then packing and repacking until it all fit!

"Its always hard to see the hardship when disaster strikes, but it was particularly disturbing to see NYC and surrounding areas as I grew up there. The pictures I was looking at on the TV were places I knew very well. I don't advise people to just head down to a disaster area and maybe becoming part of the problem. But with the internet and social media it is easy to find out how or where you can best help, they will be needing volunteers for this disaster for a long time to come. Occupy Sandy is a group always looking for help in the NYC area and they are now heading into New Jersey.



"Water, wind and fire... We had a hard time driving to some areas because of the sand and debris in the roads. I had first taken my husbands car due to more room for supplies and better gas milage, (at the time the lines for gas tied up the roadways and I didnt want to drain their limited gas supplies) but on my second trip down, I took my jeep and

was glad I did, the roads were a mess. It still doesn't seem possible, the destruction we saw. The pictures just don't capture how many homes and people are affected. In Rockaway, people in 17-story buildings, with no heat, lights, water..and....no elevator!

"On our second trip we volunteered with the Red Cross at the Miller Field staging area. We helped load four trucks full of supplies and then headed out to the neighborhoods, honking the horn to let people know we were there and going door to door, asking what people needed and helping them get it from the trucks, until the trucks were empty. They asked us to come back the next day and we did the same thing. National Guardsmen were everywhere and many church groups from New Orleans helping people muck out their homes and clearing the streets. The sanitation trucks seemed to never stop clearing debris and I could really see improvement between visits. We told the Red Cross we were headed to Breezy Point with the last of our own supplies before we headed back home

and they gave us some more of theirs to share as well. Also, I had gotten Carl's (Duford, FC) email about the Coast Guard families that needed some supplies. I could almost walk to FT Wadsworth, so Athena and I went there and found out where they were collecting and shared a large box of cleaning supplies with them as well."



### The Little Flotilla That Could

Some interesting news from the Southwest:

"One of the smallest US Coast Guard Auxiliary organizations, Flotilla 9-7 of District 11SR, was honored by Boat Owners Association of The United States (BoatU.S.) with the prestigious "Best Flotilla in the Nation" Award for 2011 at this year's Auxiliary's National Convention held August 22-26 in San Antonio, Texas. The flotilla, which has just one patrol vessel and the bare minimum number of members to sustain a unit, bested over 1,000 other flotillas from across the US for the top honors.

"Located in the southern portion of Lake Mead Recreation Area in Cottonwood Canyon on the shore of 67-mile long Lake Mohave, Flotilla 9-7's six Vessel Examiners managed to complete 1117 Vessel Safety Checks, over 400 more than the previous year. In addition, their single patrol boat, manned by 9-7's coxswains and crew, completed 21 safety patrols, verified the latitude and longitude of 33 Aids to Navigation, completed public affairs and educational missions, and provided recreational boating safety information to thousands of lake visitors."

So why do we care? It seems that our very own Peggy Burgess, FSO-MT/IS, started her Auxiliary career as a member of Flotilla 9-7 in 1998. She went on to become Flotilla Commander there and eventually Division Captain. Good news for us, she relocated back to Plattsburgh.
