In this menu you will see a '**7029 webform**' tab-- click on it and open that tab, it will take you to a page called '**Welcome to the 7029 Webform Home'** 

Along the left side of this page is a tab called '**My Webforms Guide'**-- click on it and it will take you to 'The "My Webforms Guide' page.

Heather Stewart (far right), Operations Manager for the Lake Champlain Transportation Co., Burlington, was guest speaker Oct. 21 at the Champlain Sail & Power Squadron's annual "Hauling Out" dinner meeting. About half of those in attendance were also members of the Auxiliary.

Stewart related the history of LCT (originally the Champlain Transportation Co. in 1825 to the current Lake Champlain Transportation Co. established in 1948). LCT currently operates 13 ferries on the lake and has a staff of 36 captains on rotational duty. She said the company also has an ongoing recruitment program for local young people to pursue a career as a ferry captain.

### **Boat Electronics and Engine Maintenance**

The Champlain Sail & Power Squadron, Plattsburgh, is offering two courses this fall and winter, one on boat electronics, the other on engine mechanics. Since there is a big membership cross-over between our local Auxiliary flotilla and the Power Squadron, the CSPS is offering these courses to 15-8 members at the same fee. Here's the information from Bob Shivokevich, FSO-PE and Power Squadron member:

"The Champlain Sail and Power Squadron will be offering the USPS Marine Electronics course this fall. Starting hopefully by the end of September or early October, day and time to be determined. . The course is broken down into three modules: Boat Electrical Systems, Marine Radio Communications and Marine Electronics for Navigation. The instructor is Mike Stephenson, 15-2. "The course cost for all three parts is \$45.00 (Just the cost of the book). If you only want to take the First two sections (Modules ME 101 and ME 102 the cost is \$30.00 Module ME 103 is \$30,00 so all three for \$45.00 is a bargain) I need to order the manuals so we can start on time. If you are in interested in taking the course please reply to me via email (<u>rshivokevich@yahoo.com</u>) so I can get an accurate count."

The Engine Maintenance course will be offered in late winter or early spring by instructor Frank Williams, FSO-OP 15-8 who also is a professional engine mechanic:

"The new Engine Maintenance course 2011 has been put into one ten chapter course that stresses the diagnosis of modern systems, while also teaching the basics of engine layout and operation. Gasoline inboards, outboards, and diesel engines are taught in a way that reinforces the common aspects of how engines work. This new course is complete in one book with one exam."

### **Expanded Boating Course**

Another from Bob Shivokevich, FSO-PE: "Many of you first joined the Flotilla after taking the ABS (About Boating Safely) Class. As you will remember that was an eight hour class probably broken down into 2 four hour sections.

"We covered a lot of material in that short period of time and then tested. This course did not leave much time for discussion and expansion of the course material.

"After getting some feedback from the students, Member Training Officer Peggy Burgess and I talked about trying to offer a way of expanding on that material. The Coast Guard Auxiliary offers a course called Basic Boating and Seamanship.

"This course is a 14 week course that expands on all the material covered in the ABS class and MORE. The class would meet one day a week for about 2 hours. This will give us the chance to expand on the material, and give you the chance of more discussion. In order to offer this class I would need to know who would be interested in taking this course. I need to have enough students, to make sure the Course books are available. If you are interested in taking the class or have any questions please contact me."

From time to time we run across a free website on the internet that is just so good we have to share it. However, we will not list anything here that requires a digital download or payment of money.

This was submitted by Thomas Nunes, Auxiliary Public Affairs Director:

**WASHINGTON -** The Coast Guard Auxiliary has joined forces with the Alliance for Safe Navigation to inform boaters of the importance of maintaining current navigation information. Alliance members include the National Oceanic and Atmospheric Administration (NOAA), BoatUS, Jeppesen Marine, the U.S. Power Squadron, OceanGrafix, and the Sea Tow Foundation for Boating Safety and Education.

Surveys have revealed that most boaters are not concerned about the accuracy of their charts and related navigation information. More than three quarters do not pay attention to local notice to mariners issued by the Coast Guard. The Coast Guard Auxiliary will utilize its Alliance partnership to promote boating safety.
