

Blessings of the Fleet bring Recreational Boaters Together

On Sunday July 1st, 2012, the United States Coast Guard Auxiliary Flotilla 10-13, of the 1st southern region, hosted a "Blessing of the Fleet" for vessels of Greenwood Lake. The day was introduced by Michele Rollino, Flotilla Commander, promptly at one o'clock in the afternoon. Then the service was presided over by Pastor Jack Traugott from Grace Evangelical Lutheran Church in Greenwood Lake, NY.

The boats were blessed from the balcony of Auxiliary member Donna Breurs' boathouse which is located mid-lake. Following a short ceremony and remembrance, Pastor Traugott energetically gave a personal blessing and well wishes to each mariner and their vessel as they passed below. Led by Priority One, an Auxiliary Patrol Vessel with coxswain Pat Ermilio and crew Donna Formato, a parade of over twenty boats made their way to receive the anointment and share in this special day. A couple of row boats joined the line of pontoons, motor boats and sailing vessels. The weather was very pleasant on this day, sunny with enough scattered clouds to keep cool and a couple later afternoon thunderstorms that could be heard echoing off the surrounding mountains. The year prior event was rained out and postponed one day to a Monday, and that greatly affected the turnout then. The participation and enthusiasm of so many on the lake this year was truly uplifting and strengthened the bond that mariners already share.

Greenwood Lake, an intrastate lake spanning New York and New Jersey, is the summer home of flotilla 10-13 and Station Greenwood, the Coast Guard Auxiliary detachment based on the water there. Public Education, Vessel Safety Exams, Marine Safety Patrols, Environmental Protection and Recreational Boating Safety keep the members of the Auxiliary busy for the boating season on the lake and also on patrols in the Hudson River and NY Harbor. USCG Aux 10-13 is based out of Wyckoff, NJ and meets monthly in The Larkin House, a community center owned by the town.

Ms. Breur hosted a Barbeque and gathering after the "Blessing" event, attended by members of 10-13, other local Coast Guard units, Gus Formato, District Commander, and many members of the boating community. While the shared company was good and the talk was vast in subject the idea of the "Blessing": the safety of the boating public is never far from the minds in this crowd. "Semper Paratus".
