DISR Crews:

Extreme shoaling in all the South Shore Inlets is becoming huge problem for mariners and the Coast Guard.

The 47' Coast Guard rescue vessels out of Station Fire Island has been prohibited from entering Fire Island inlet.

In addition Moriches and Shinnecock Inlets are experiencing dangerous shoaling where boats are bumping the ground.
